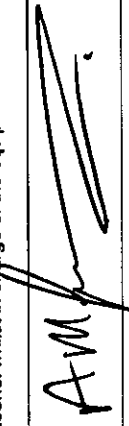


MUNKEE BIZNESS RISK ASSESSMENT – Side Stalls

Persons Involved: Munkee Bizness Employees and general Public	Describe Activity / Equipment: Our side stalls are the following equipment:- Commercial grade pop up gazebo's with Velcro and zip attachable side walls. Each game is made from wood - Duck Hunt uses a small low powered childrens nerf gun with sponge bullets. These are aimed at ducks from a distance of 2.5 metres - Coconut shy use coconuts suitable for indoor use with 'soft play balls' to ensure safety at all times. - Ball in a bucket is a series of 3 tin buckets with 3 tennis balls used to throw into the buckets - Slam Dunk uses soft balls to be thrown into nets - Ping Pong challenge uses plastic fish bowls and ping pong balls - All games are operated from behind a bar on the front of the marquees The side stall can be installed both indoors and outdoors with the use of stakes or sandbags where appropriate	Location:
